#### **Required Documents**

Official transcripts must include: the institution's official seal; registrar's signature (this is usually a stamp); and two forms of student identification (e.g., Social Security number and current address, or current address and date of birth). Note: The issuance date of the transcript must be within three weeks or less. Do not submit unofficial copies as they cannot be used to evaluate your prior credits.

NOTE: Test must have been taken within the last two years of applying to Excelsior College.

- 2. Successful completion of Excelsior College's ENGx111: English Composition or the UExcel® ENGx110 College Writing examination.
- 3. Submission of evidence of the successful completion of at least 9 credit hours of academic work in courses delivered in English at an institution of higher education in the United States.

### School of Nursing, International Nurses Only

In addition to official transcripts, nursing candidates must demonstrate that they have an equivalent U.S. Registered Nurse (RN) licensure. To be eligible for admission, the applicant must be a graduate from an approved school of nursing in their country of education and hold a current, unencumbered nursing license (if licensed in multiple jurisdictions and/ or countries, all licenses must be unencumbered). All nursing school transcripts and all licenses will be validated by primary source verification.

International candidates must apply to the Commission on Graduate of Foreign Nursing Schools (CGFNS) New York Credential Verification Service (NYCVS) and the New York State Education Department (NYSED) to have their foreign nursing education evaluated and approved by the aforementioned organizations. Since NYSED only issues an official NCLEX eligibility document to applicants directly, and will not send the document to Excelsior College, international applicants must forward the unopened official NCLEX eligibility document to Excelsior College. When international applicants receive the official NYSED document in its sealed envelope, they must insert the unopened envelope into an outer envelope and forward it to Excelsior College. International applicants should also write their full name, permanent address, and date of birth on the outer envelope.

For the evaluation of credentials from outside the United States, all applicants must use one of the approved agencies noted previously. CGFNS New York Credential Verification Service (NYCVS) and the International Consultants of Delaware (ICD) Course by Course Services are offering Excelsior College applicants a discount when using their combined services. This bundle service package represents

significant savings with a discount being applied to the ICD Course by Course Service. This one-stop service helps applicants reduce expenses and save time in completing all the required procedures necessary for admission. All official documents must be in sealed envelopes from the original source. In the event that Excelsior College receives an opened document, it will be considered unofficial and will not be considered for eligibility or evaluation; the opened document will be returned to the applicant. In this case, it becomes the applicant's responsibility to contact NYSED or ICD and request another official copy to be forwarded, unopened, to Excelsior College by the applicant.

#### **Guidelines for the Admissions Essay**

The admissions essay is your opportunity to explain your interest in earning a Master of Arts in Liberal Studies from Excelsior College. This essay is the primary means by which we will assess your preparedness for the program. Because good writing skills will be very important to your success in this program, we will use your essay to assess your ability to communicate effectively in writing. Therefore, the essay should represent your best writing effort.

In a direct, concise essay of 800–1200 words, your personal essay should address how the MALS program can help you achieve your personal, professional, and academic goals; your preparedness for graduate-level study; your experience and/or aptitude for completing academic work at a distance; and any special abilities, qualities, or life experiences you will bring to the program.

There are two options for students wanting to complete the MALS degree: the Capstone option and the Thesis option. For the Capstone option, students take an 8-week Capstone course designed to allow students to showcase their skills in performing interdisciplinary study of a topic presented in the course, ending with a culminating project. Students choosing the Capstone option should note that in their essay and also discuss why interdisciplinary studies is important to their goals. Alternatively, students may choose the Thesis option in which the program concludes with the 15-week Thesis course and submission of the Master's Thesis. Students specifically interested in the Thesis option should note that in their essay and also explore an area of focus that they wish to examine throughout the program and for their thesis.

**NOTE:** Because good writing skills will be very important for your success, the essay will be used to assess your ability to communicate effectively in writing. Therefore, the essay should represent your best writing effort.

#### **Guidelines for the Admissions Essay**

In the pursuit of graduate education, a student's ability to communicate effectively in writing is an absolute necessity. A candidate for admission to the Master of Science in Criminal Justice program is required to submit a personal statement essay with their application. This essay is designed to provide the candidate with an opportunity to explain to the admissions committee why he or she is interested in pursuing the M.S.C.J. and serves as a sample of the candidate's writing ability. The essay should be creative, organized and original. The use of correct grammar, punctuation, spelling and syntax are essential.

In a 1200-1500 word, double-spaced essay, convey how graduate study enhances your career goals. Also discuss related qualifications including academic preparedness, professional

experience, and/or community activities, and any other significant accomplishments. Please indicate any previous experience with online education.

Upon completion of the applicant's admissions file, the MSCJ Admissions Committee will review all applications and may grant or deny admission to the program. Cohorts begin throughout the year. Applications will be considered on a rolling basis.
