Thank you for your interest in Excelsior College.

School of Nursing students: All nursing students must apply for admission prior to enrollment. If you were previously admitted to the School of Nursing more than six months ago, you must re-apply for admission.

If you have been withdrawn from a **business**, **health sciences**, **liberal arts**, **public service**, or **technology** degree program within the last five years, please contact your Academic Advising Office as you may not be required to submit an application.

If you are a graduate of a **business**, **health sciences**, **liberal arts**, **public service**, **technology**, or **nursing** degree program, please contact your Academic Advising Office as you may not be required to submit an application.

Required Documents

Official transcripts are required as part of the application process. With your permission, Excelsior College will request official transcripts on your behalf from all accredited, credit bearing institutions you have attended. If you opt out of this service and elect to request your own official transcripts please note that official transcripts/documents are those that a college, testing agency, or education office submits directly to Excelsior College, Office of Registration and Records, 7 Columbia Circle, Albany, NY, 12203-5159. Official transcripts must include: the institution's official seal; registrar's signature (this is usually a stamp); and two forms of student identification (e.g., Social Security number and current address, or current address and date of birth). **Note:** The issuance date of the transcript must be within three weeks or less. Do not submit unofficial copies as they cannot be used to evaluate your prior credits.

School of Business & Technology

Course descriptions must be submitted with official transcripts. Time limits on transfer credits are outlined as follows.

Business Degrees Candidates

Business courses that are more than 20 years old **will not** be counted toward the business component of the degree and **cannot** be appealed.

■ Technology Degrees Candidates

Computer information systems/computer sciences courses for the Bachelor of Science in Information Technology have a 10-year time limit from date of enrollment, and they cannot be appealed.

Electronics/computer courses for degree programs other than the Bachelor of Science in Information Technology have a 10-year time limit, which can be appealed.

Transfer credits for which an appeal can be made require submission of a completed time limit appeal form with this application. The time limit appeal form can be downloaded from our website at **www.excelsior.edu/TimeLimitAppeal** (requires a free MyExcelsior website user account).

School of Nursing Candidates

In addition to official transcripts, we must verify your admissions eligibility via your license or certification in an appropriate health care profession. In most cases our office will be able to verify the validity and currency of your license/certification. However, if we are not able to do that we will contact you and request that you submit this documentation to us. Bachelor of Science in nursing (BRN) and RN to Master of Science in nursing (MRN) applicants must submit an official transcript showing the completion of associate degree nursing education or RN diploma education. Nursing courses completed at regionally accredited institutions other than Excelsior College are only evaluated upon enrollment.

Financial Assistance

You must first complete the FAFSA (Free Application for Federal Student Aid) in order to be considered for any form of financial assistance. International Transcripts

In order for Excelsior College to consider credentials from outside of the United States, you must submit an application to the agency below to have your foreign credentials evaluated:

International Candidates

International candidates from non-English speaking countries must show evidence of sufficient English language proficiency through **one** of the following three options:

- 1. Submission of TOEFL (Test of English as a Foreign Language) with a minimum score of 525 on the paper-based test or 69 on the Internet-based test; MELAB (Michigan English Language Assessment Battery) with a minimum score of 75, or IELTS (International English Language Testing System) with a minimum overall band score of 5.5. NOTE: Test must have been taken within the last two years of applying to Excelsior College.
- 2. Successful completion of Excelsior College's ENGx111: English Composition or the UExcel ENGx110 College Writing examination
- 3. Submission of evidence of the successful completion of at least 9 credit hours of academic work in courses delivered in English at an institution of higher education in the United States.

International Nurses School of Nursing Candidates

Admission to the associate degree in nursing programs is not open to international students. For the other programs, in addition to official transcripts, nursing candidates must demonstrate that they have an equivalent U.S. Registered Nurse (RN) licensure. To be eligible for admission, the applicant must be a graduate from an approved school of nursing in their country of education and hold a current, unencumbered nursing license (if licensed in multiple jurisdictions and/or countries, all licenses must be unencumbered). All nursing school transcripts and all licenses will be validated by primary source verification.

International candidates must apply to the Commission on Graduate of Foreign Nursing Schools (CGFNS) New York Credential Verification Service (NYCVS) and the New York State Education Department (NYSED) to have their foreign nursing education evaluated and approved by the aforementioned organizations. Since NYSED only issues an official NCLEX eligibility document to applicants directly, and will not send the document to Excelsior College, international applicants must forward the unopened official NCLEX eligibility document to Excelsior College. When international applicants receive the official NYSED document in its sealed envelope, they must insert the unopened envelope into an outer envelope and forward it to Excelsior College. International applicants should also write their full name, permanent address, and date of birth on the outer envelope.

The evaluation of credentials from outside the United States, all applicants must use one of the approved agencies noted previously. CGFNS New York Credential Verification Service (NYCVS) and the International Consultants of Delaware (ICD) Course by Course Services are offering Excelsior College applicants a dis-

count when using their combined services. This bundle service package represents significant savings with a discount being applied to the ICD Course by Course Service. This one-stop service helps applicants reduce expenses and save time in completing all the required procedures necessary for admission. All official documents must be in sealed envelopes from the original source. In the event that Excelsior College receives an opened document, it will be considered unofficial and will not be considered for eligibility or evaluation; the opened document will be returned to the applicant. In this case, it becomes the applicant's responsibility to contact NYSED or ICD and request another official copy to be forwarded, unopened, to Excelsior College by the applicant.
